The Algosaibi's of the 1800s transported goods between the fertile coast of the East of the Arabian Peninsula and the scorching sands of its central region of Najd. They were entrusted to collect taxes in Huraymlah on its governor's behalf. Like many Najdi families of prominence in the 1880s. the Algosaibi's, constrained by the devastating drought have relocated to the Eastern Province of Al-Ahsa in 1885. Shortly the presence extended to Bahrain. From these two key locations began the parallel stories of wealth and influence that defined the family for the centuries to follow.

A. Algosaibi, the eldest son of Khalifa Abdulrahman, was born an ambitious entrepreneur forward-looking with business ideas. unconventional to his time and region. With very limited resources, he founded a business supplying the Saudi army with food imported from Egypt, delivered through the port city of Jeddah.

The Algosaibi's trade expansion and their multiple social, political and economic roles upheld the family as key players in the Arabian Peninsula's history. With pearling at the heart of the Algosaibi's businesses, the introduction of Japanese cultured pearls during the 1930s had an inevitability vast impact on finances.

In 1950 Khalifa A. Algosaibi has cofoundedGulf Aviation company which later become Gulf Air, in 1963, Khalifa A. Algosaibi, aided by Aramco's Local Industrial Development Department, successfully established the Khalifa Algosaibi Fishing Company, owning at its peak over sixteen trawlers and exporting to the United States of America over \$5 million worth of shrimp under the brand name "Ocean Reef".

In 1964, the Khalifa A. Algosaibi Holding Company expanded into the field of specialty commercial diving with the establishment of the Algosaibi Diving and Marine Services Company (ADAMS). In 1968 further expanded to FMCG distribution through Khalifa Algosaibi Cold Stores Co. (KACS).

This period witnessed the Group's expansion to include Hospitality and Catering (AGS), Spectrum Chemicals, a trusted manufacturer in the United Kingdom of polyurethane and specialty construction systems, construction of the Algosaibi Residential Compound (Las Dunas) as well as establishment of Saudi Road Marking Co. Ltd (ROMAC) and National Road Studs Co.(NRS). Determined to grow without interruption, Khalifa A. Algosaibi continued to invest in new businesses in the 1980s, adding to his already impressive portfolio the Sigma Paints in 1981 as a joint venture with PPG Industries, Construction Materials Chemical Industries (CMCI) in 1984, and the Arabian Vermiculite Industries (AVI) in 1985.

The Khalifa Algosaibi Trading Company (KAT) was established in the 1990s, along with the Algosaibi Oil Field Services Company (AOS).

In 2017, we restructured, transforming the Holding Company into a Closed Joint Stock Company under the current name of Khalifa A. Algosaibi Investment Co. (KAI). In 2020, KAI acquired AsasTraining Institute (ATI), which now delivers top-quality vocational training. That same year, KAI participated in establishing Silver Star, a logistics service company.

In line with Vision 2030 and meeting international demands, we established the Specialized Industrial Casting Company (SICAST) in 2021. Equipped with state-of-the-art machinery and managed by experienced professionals with key roles in renowned steel foundries across Europe, the Middle East, and India, SICAST is well positioned to contribute to Saudi Arabia's economic transformation and prosperity. We are dedicated to executing complex customer projects, forging effective partnerships, and building on our rich legacy, deep expertise, and extensive network.
